

## Nathaniel Burton of Buckingham County, Virginia

- 1764 **Buckingham Co., VA.** Tithables.<sup>1</sup> Names in parentheses are probably slaves.  
**Robert Burton** (Cate) 2 male tithes 0 acres 0 wheel carriages  
**William Burton** (Simon, Peter) 3 male tithes 400 acres 0 wheel carriages  
**Isaiah Burton, Sr.** (Sipyon, Dick, Sarah, Masse?)  
5 male tithes 200 acres 0 wheel carriages  
**Nathaniel Burton** (Corey) 2 male tithes 800 acres 0 wheel carriages
- 1773 **Buckingham Co., VA.**<sup>2</sup>  
**Josiah Burton**, 6 tithables. [is this Isaiah?]  
**Nathaniel Burton (Wm. Burton)**, 6 tithables.  
**Robert Burton (Isaac Burton)**, 2 tithables.  
**William Burton**, 1 tithable.  
**John Jones (John Jones, Jr., Thomas Jones, William Burton, Thomas Jones)**, 10 tithables.<sup>3</sup>  
**John Phelps (Adrain Anglin, Jacob Burton)** 4 tithables<sup>4</sup>
- 1774 **Buckingham Co., VA.**<sup>5</sup>  
**Isaiah Burton**, 6 tithables.  
**Nathaniel Burton (Wm. Burton)**, 6 tithables.  
**Robert Burton (Isaac Burton)**, 2 tithables.  
**William Burton**, 1 tithable.  
**John Phelps (Adrain Anglin, Jacob Burton)** 5 tithables<sup>6</sup>  
**John Jones (John Jones, Jr., Thomas Jones, William Burton, Thomas Jones)**, 9 tithables.<sup>7</sup>
- 1782-1812 **Buckingham Co., VA.** **Nathaniel Burton** is of this county.<sup>8</sup>
- 1786 **Buckingham Co., VA.** **Nathaniel Burton** received a new grant of 400 ac.<sup>9</sup>
- 26 Jan 1786 **Buckingham Co., VA.** **Nath'l Burton**, 321 ac.; adjacent to **Edward Maxey, Widow Norcutt, Nath'l Maxey and Edward Maxey.**<sup>10</sup> NOTE RECORD BELOW:

- 26 Jan 1786 **Buckingham Co., VA. John Sanderson**, 76 ac.; joining **Nath'l Maxey, Mr. Halls, and ---- Smith**.<sup>11</sup> (John Sanderson married Elizabeth Burton, daughter of Nathaniel Burton.)
- 1786 **Buckingham Co., VA. Nathaniel Burton** has a grant of 400 ac.<sup>12</sup>
- 15 Nov 1794 **Buckingham Co., VA. Nathaniel Burton** signed a petition of residents of Buckingham to the General Assembly to ask that the lands of the Glebe in Tillotson Parish be disposed of and the money arising from the sale be used for payment of parish levies or any other purpose deemed proper.<sup>13</sup> **John Burton** also signed.<sup>14</sup>
- 19 May 1798 **Buckingham Co., VA. John Maxey**, 307 ac.; adjoining **Nath'l Burton, Edward Maxey, Charles May, Gad Blankenship, Richard Bondurant, & Elijah Howle** on Goodwin's Road.<sup>15</sup>
- 1798 **Buckingham Co., VA. Nathaniel Burton** bought 350 ac. from **George Babar**.<sup>16</sup>
- 1800 **Buckingham Co., VA. Nathaniel Burton**, 1 white male, 6 horses, 4 negroes, 1 negro 12-16.<sup>17</sup>
- 1806 **Buckingham Co., VA. Benjamin Burton & Nathaniel Burton** sold 315 a. to **Nathan Ayres**.<sup>18</sup>
- 1810 **Buckingham Co., VA. Nathaniel Burton** sold 125 ac. on Muddy Creek to **William Burton**.<sup>19</sup>
- 1810 **Buckingham Co., VA. Nathaniel Burton**, federal census, 1 male 45/older (b. 1765/earlier), 1 female 45/older (b. 1765/earlier, 3 slaves).<sup>20</sup>
- 1811 **Buckingham Co., VA. ---- Burton** sold 200 ac. to **Josiah Hatcher**.<sup>21</sup>
